St. John will host Sub-State Volleyball on October 22nd.

Mr. Meyer showed the board some information on student data on how many kids are below and above the target on assessment scores. Anti-Bully Awareness Week was last week. Each day the kids and staff wore a different color to show their spirt for the week. Next week is Character Counts week, a program the elementary is using to instill a positive learning environment. Mr. Meyer is serving on a Special Ed funding committee with the cooperative. The board was given some handouts regarding the state budget. A state general fund profile showed the state's financial position over the past 5 years. Vonfeldt, Bauer & Vonfeldt will present the audit report to the board next month.
