Derek Foote moved and Carl Behr seconded that the Board of Education of Unified School District No. 350 expressly find pursuant to K.S.A. 72-8212(d), that the Board of Education accept the offer of Marjorie Ann Ritter to purchase a tract of real estate herein below generally described from the school district, such property being considered as excess and that is in the best interest of the school district to sell such real estate. Chad Fisher, Board President with attestation by Alisa Fisher, Board Clerk, are specifically granted authority on behalf of the Board and school district to execute a Contract of Sale of Real Estate setting out the terms and conditions of such sale including the sale price of \$7,500.00 payable upon approval of title and final closing of the transaction.

The real estate subject to sale is described as follows:

Addition 1, Block 4, Lots 8 & 9 & North 15 feet of Lot 10, Stafford County, Kansas, together with all appurtenances thereunto belonging, subject however to a more formal description of the property upon completion of a survey as requested by the buyer. The President of the Board of Education with attestation by the Clerk of the Board shall also have express authority to execute the deed of conveyance of the subject real estate to the buyer upon approval of title and closing the sale transaction.
