APPROVE AMENDED BUDGET

President Fisher asked for any questions regarding the budget amendment. Being none, he asked for a motion for approval.

Tom Garner moved and Barbara Alpers seconded the motion to approve the amended budget as presented.

2013-2014 FINANCIAL AUDIT

Mark Bauer with VonFeldt, Bauer & VonFeldt, Chtd. presented the 2013-2014 financial audit to the board. He distributed materials relating to the audit and the audit report. He then went over the management letter with the board. He proceeded to review final adjustments and the audit letter. He then reviewed the audit report with the board.

Tom Garner moved and Barbara Alpers seconded the motion to approve the 2013-14 financial audit as presented.

BUS PURCHASES

The board has discussed various solutions for our transportation fleet. We currently have one bus in need of replacement and another bus that needs replacement very soon. Information about the district's current fleet was included with the board packet.

The recommendation is to replace 2 buses right away. The superintendent proposes purchasing a large activity bus and a small route bus.

Carl Behr moved and Tom Garner seconded the motion to approve the purchase of a small bus not to exceed \$50,000 from the KS Bus Purchasing Program.

WEIGHT ROOM

It is recommended to move the weight room into the school building. The cost will be minimal to the district and the superintendent recommends making the move this summer.

Stan Woodward moved and Vance Fisher seconded the motion to approve relocation of the weight room to the main building.

2015-2016 FEES SCHEDULE

The schedule of fees was presented. Meal prices were not set at this time. It is anticipated that meal prices will increase by 10 cents or less. The sports participation fee was included as an item of discussion but was not included in the fee schedule.

2015-16 STUDENT HANDBOOK

The draft of the student handbook was included in the board packet. Administration staff has worked to combine the Elementary and Jr/Sr High handbooks into a single document. This allows for more consistency throughout the district. This handbook should be carefully considered as it becomes official board policy.

Tom Garner moved and Stan Woodward seconded the motion to approve the 2015-2016 student handbook as presented.

KASB DUES AND LEGAL ASSISANCE FUND

The board is a member of the Kansas Association of School Boards (KASB) and also a member of the KASB Legal assistance Fund. It is recommended that the board continue membership in the association as well as the legal assistance fund. The fee for each is the same as last year and we get great benefit from both.

Carl Behr moved and Bill Milton seconded the motion to approve the dues of \$4,933 for 2015-16 membership in KASB and the fee of \$1,650 for the legal assistance fund.

JUNIOR HIGH FOOTBALL

The district has discussed the potential of a cooperative agreement for next year's junior high football. The district believes it has enough players signed up to have our own JH football team next year rather than cooperate with Macksville.

GUIDELINES FOR 6TH GRADE ATHLETICS

Guidelines for administrators to determine whether 6th grade students should participate in junior high athletics are included in the board packet. It is recommended that the board approve these guidelines. This will give administration direction to make these decisions rather than asking the board to take action for each individual situation.

Vance Fisher moved and Barbara Alpers seconded the motion to approve the guidelines for sixth grade athletic participation.

Vance Fisher commended staff on how well track meets are run at all levels. President Fisher attended special education cooperative meeting.

Mr. Olive reported on the elementary building. Enrollment remains the same. The elementary building received a student achievement award from Lexia for improvement in reading. The elementary track meet was held Friday May 8 and was a success. Pre-school and kindergarten graduation will be Monday

May 18 in the main gym. Last half day of school is Tuesday, May 19 with dismissal at 11:00 a.m. Teachers last day is Wednesday, May 20.

Mr. Burgan reported on the high school building. Three students performed at State Music in Salina. Brooke Shultz earned a 22 for her vocal solo and Bella Haskins-Martinez earned a 1 for her vocal solo. Taylor Clark earned a 1 for both her vocal and snare drum solos. The HS band and vocal performance was held May 5. The Honors luncheon was held May 6 in the courtyard. The CPL Art contest was Aprill 22 with Kerisa Brown taking 2nd in photography; Baley Doggett a secon in ceramics; Brandi Hanson a 5th for painting; Andrea McCall a 4th in ceramics and Anna Stryker with a first in ceramics, 4th in painting, 3rd in sculpture and Best in Show 2D. JH Activities Banquet was held on April 27. HS Activities Banquet is Tuesday, May 12. Graduation will be on Saturday May 16 at 4:00 p.m. Senior activities include Baccalaureate on May 13 at 7:00 p.m. and Senior Class night on May 15 at 7:00 p.m. Mr. Meyer presented a video on students in the district who are part of the Career and College Readiness program. He updated the board the new board member workshop attend by the incoming board members, hail damage to district vehicles, a 4% increase in employee health insurance costs, and the agent change for the district's building & liability insurance and workers compensation insurance package.
