Notes from the Superintendent

We are excited to be gearing up for the start of another school year. We hope that this newsletter will keep district patrons and families informed about our district and communicate important information about the start of the school year.

I remember vividly back in March of 2020 when the unprecedented decision was made to effectively shut down schools for the remainder of the year. The pandemic became very real for us all at that point. We struggled through remote learning that spring and then kids returned to in-person learning last fall. They

were all very excited to be back in the buildings, and the staff and teachers were also thrilled to have them back. We all had to make adjustments and struggle our way through the unknowns.

To say it simply, last year was a mess. I did feel very fortunate that we did not have the difficulties that other communities and schools experienced. We didn't know how to handle much of anything, but we did our best and made it through the year.

I am so proud of how our staff, students, parents, and community members handled this tough situation. While I know we did not have 100% agreement on anything,

everyone was willing to accept the reality and do what it took to keep our kids in school.

We are now to a point where we are nearly getting back to normal. While this global pandemic is not 100% over, we anticipate starting the school year pretty much as we did before March of 2020. But we will still need to be cautious. We do not anticipate needing to have drastic measures in place such as requiring masks and temperature checks. We do, however, anticipate dealing with the potential for quarantines.

As of today, CDC guidelines state that anyone who has been exposed to Covid should quaran-

Online Student Enrollment

Student registration will be done online once again this year starting the first week of August. Information about enrollment and links for the online enrollment portal are on our website.

An email will be sent to parents with instructions and a special code needed for the enrollment process. If we do not have a valid email in our system, a letter will be mailed to parents with detailed instructions and the special code. IF YOU DO NOT GET AN EMAIL OR RECEIVE A LETTER BY AUG 9TH, PLEASE CONTACT THE OFFICE.

Parents of students who are new to the district will need to create an online account to start the process. See our website for the link.

There is an option to pay online or you can choose to mail payment. If there is a discrepancy with any dollar amount that is owed, just choose the cash/check option and we will fix it here in the office.

Proof of identity must be provided for students en-

rolling in a school district for the first time. Proof of identity can be a birth certificate, SS card, a copy of a court order placing a child in the custody of DCF, or a certified transcript or similar pupil records from another school district where the student was previously enrolled.

A doctor's physical is required for students who are enrolling for the first time in the state of Kansas. Students who were previously enrolled at USD 350 or another Kansas school do not need to have an additional physical exam. You should contact the Health Department or your doctor if an exam is required.

To enroll in kindergarten, a student must be 5 years old on or before Aug 31st. To enroll in first grade, students must be 6 years old on or before Aug 31st OR have completed an accredited Kindergarten program. These age limits are established by state law and the school district has no flexibility to adjust these requirements.

tine for 10 days. Those that have been fully vaccinated and those that have tested positive within the last 3 months do not need to quarantine.

Covid vaccinations will not be required for students to attend school. However, the more staff and students we have vaccinated, the less we have to worry about quarantines and the spread of the virus. If you are considering getting your eligible student vaccinated (ages 12 and up), contact the Stafford County Health Department 620-549-3504.

We will not be able to offer remote learning for students on an individual basis this year. New state law actually limits the amount of time students can learn remotely unless it is through a registered virtual school. We did our best to provide remote learning during the pandemic, but we just are not equipped to provide a quality education to those in the classroom and those learning from home at the same time.

My hope is that we can get this school year up and running in a mostly normal fashion and continue that throughout the school year.

This year's calendar structure is very similar to what we have had in the past. Spring break will be the same for most schools and colleges this year. The calendar can be found on our website and printed copies are available to send home with students or be picked up in the school office. You can also download the Google calendar to your smartphone or other device.

The USD 350 Board of Education meets regularly on the second Monday of the month at 7:00pm in the basement of the library (6:00pm during the winter months). Board meeting agendas and minutes can be found on the district website or can be requested from the district office. Board member names are listed on the front page of this newsletter.

There is an election coming up in November for boards of education. Vance Fisher, Shawn Ward, and Carl Behr have all filed to run for their current positions and are all running unopposed.

Our staff always stays focused on our mission to "ensure that students will find their purpose and become successful, lifelong learners and positive contributors in a changing world." ## Early Education at USD 350

It is the goal of USD 350 to provide preschool for all children starting at age 3. Preschool students attend class for a half day Monday through Thursday in the morning or the afternoon. Preschool will be in session on some Fridays in order to meet state time requirements. The first day of preschool is Aug 19th.

Our preschool is operated jointly by USD 350 and the special education cooperative in Pratt. Students must go through the screening process to be eligible to attend preschool. The next screening in St. John will be Thu, Aug 5th at the Library from 9:00 to noon. Call 620-672-7500 Ext 1203 to make an appointment.

For the most part, children must also be toilet trained before attending preschool. If you have any questions, please feel free to contact the elementary office.

## Student Insurance

## LIFE After-School Program

The L.I.F.E. After-School Program is available to all students (K- 4th grade) enrolled in USD 350. Enrollment in the program is only \$20 per month. The program runs every day immediately after school until 5:10 pm. We provide a snack, an academic lesson and a variety of other fun, age-appropriate activities. The elementary program is on an enrollment basis and has a low monthly fee. Parents/guardians may choose to send their student five days a week or pick the days that best meet their needs.

On a non-enrollment, no cost basis, we also have tutors available to assist any K-12 student with their school work. Tutors are available for one hour each day after school. This service is also located in the library. Students may come in as needed for tutoring.

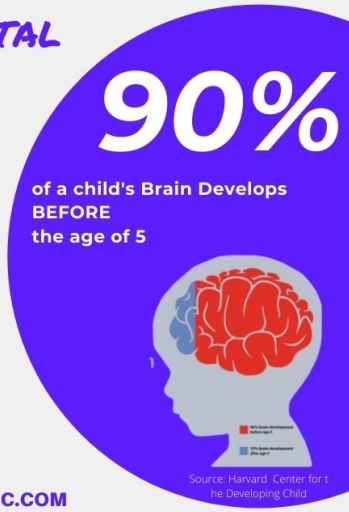

**Fall Sports Information**

**\*Parent Meeting, Thursday, August 12th 6:30 pm in the main gym.**  
***All JH/HS students who will be participating in a fall sport should attend with their parents.***

**\*All athletes are required to have a new physical exam completed each school year (after May 1, 2021). Athletes must have a state-approved physical form turned into the office before they may participate.**

**Practices begin August 16th**

6th grade students may participate in junior high sports if participation numbers allow. Girls may participate in volleyball and all may participate in cross country. State law does not allow 6th graders to play football.

**Preliminary Budget Information**

The school district's budget for the upcoming year is not much different than prior years. There is a roughly 3% increase in general state funding for K-12 education this year. This is a positive thing for school districts in our state. However, some of that is masked by increasing costs for special education that are covered by state funding. The state is putting additional funds into special education, but it is a fraction of what inflation is each year. This has put the state funding of excess costs for special education at below 70% when state law calls for 92%.

Our school district budget is controlled by state funding, local taxes (property values and mill levy), and student enrollment. Property values in the district have increased by about 8% overall. The effect of this is that the overall mill levy will drop a bit. Last year's mill levy was 51.8 and this year, when the budget is finalized, the mill levy is anticipated to be down to about 50.2 (see the graph below for a historical look).

The mill levy fluctuates from year to year because of the change in property valuation in the district. The valuation is fairly volatile because some of it is tied to oil prices. In general, if the valuation goes up, the mill levy comes down. That's what we are seeing with this year's budget.

Each year the district's budget is published in the newspaper and then the board of education holds a public hearing before approving the budget. The budget will be published sometime in August and the board will hold the hearing at their regular meeting in September.

There has been a significant influx of funding provided by the federal government to help manage operating schools during the pandemic over the past year and more is available for the next two years. The primary use of last year's funds were for technology for remote learning, additional personnel to manage the crazy year, and health equipment like thermometers and PPE.

Moving forward, additional funds are provided. Our focus is on helping students recover from learning loss due to the pandemic and addressing air quality (windows, HVAC, etc) to help mitigate any virus spread as well as addressing facility needs.

This year, the state legislature passed a new law changing the publication and hearing requirements for school districts and other municipalities. The revenue neutral rate (RNR) is the mill rate that that would generate the same level of tax revenue for the upcoming budget year. It is important for taxpayers to understand how they are affected by local entities that levy taxes. That's why there have always been measures to ensure public transparency are uniform across our state. We have always adhered to those requirements and have gone above those requirements to make information available to our patrons on our website beyond what is required by law.

The problem with this new law is that state statute requires that school districts levy 20 mills for the general fund. But the revenue neutral rates is 18.4 mills. This means that the district will almost certainly exceed the RNR every single year. The only way that any school district does NOT exceed the RNR is if property values decline. This does happen especially when the values are tied to the price of oil and gas as explained above. This year's budget will exceed the RNR. That being said, the mill levy will drop by about 1.6 mills.

In addition to the school mill levy, the district also collects taxes on behalf of the recreation commission. The recreation commission sets their own budget, the taxes are levied by the school district, and passed on to them. This levy is very similar to what it is every year 3.7 mills.

## From the Nurse's Office

During the 21-22 school year I will continue to offer Covid 19 Testing to students and the community. In addition to rapid covid testing, students will also be eligible to be tested for strep and influenza. These free rapid tests are available due to a grant from KDHE.

If your child will be taking prescription medication while at school or carrying an inhaler, you will need to fill out a form for the nurse's office. Remember to have your doctor write the child may carry his/her inhaler on the medication form. Students in 7th-12th grade are allowed to carry over the counter medications in their backpacks if they have a permission form on file. You can download those forms on our website under "District>Nurses Office." Please send those forms to school with your student or you can turn them into the school office during business hours.

Please bring proof of any new immunizations to the school office.

Pre school, Kindergarten and new students eight years old and under will need a completed health assessment. This will need to be turned into the office before the first day of school.

- Proof of identification (birth certificate, SS card)
  - Health assessment
  - Immunization records
