Notes from the Superintendent

It is not really healthy to dwell too much on the past. It is more helpful to look forward. However, it is always important to know where we have been in order to understand where we are heading. As we head into the start of a new school year I find myself thinking about how students have not had a full, normal school year in the last three years. The students who will be in third grade this year have not experienced a full, normal school year in their lives, aside from their half-day preschool experiences. While things have been pretty much back to normal around here since January, the lingering effects of lost quality time in school will be evident for some time to come.

We have not needed to issue any official an-

nouncement or take any action about Covid since last winter. It obviously did not go away, but we have been able to deal with the situation as necessary at the local level. That being said, Covid is still around. As we move forward, it is the intention of the school board and administration to have no requirements about masks or quarantines this year. We are planning to be in school and hold activities as we did in the second half of last school year.

Part of the process of looking forward is the development of a strategic plan for the school district. Last spring, the board of education held two meetings with around 50 staff members, parents, and patrons to get input on our district improvement efforts. There were quality discussions and two important themes emerged. One is the need for facility improvements. Having old buildings is an ongoing

Online Student Enrollment

Student registration will be done online once again this year starting the first week of August. Information about enrollment and links for the online enrollment portal are on our website.

An email will be sent to parents with instructions and a special code needed for the enrollment process. If we do not have a valid email in our system, a letter will be mailed to parents with detailed instructions and the special code. IF YOU DO NOT GET AN EMAIL OR RECEIVE A LETTER BY AUG 8TH, PLEASE CONTACT THE OFFICE.

Parents of students who are new to the district will need to create an online account to start the process. See our website for the link.

There is an option to pay online or you can choose to mail payment. If there is a discrepancy with any dollar amount that is owed, just choose the cash/check option and it will be fixed in the office.

Proof of identity must be provided for students en-

rolling in a school district for the first time. Proof of identity can be a birth certificate, SS card, a copy of a court order placing a child in the custody of DCF, or a certified transcript or similar pupil records from another school district where the student was previously enrolled.

A doctor's physical is required for students who are enrolling for the first time in the state of Kansas. Students who were previously enrolled at USD 350 or another Kansas school do not need to have an additional physical exam. You should contact the Health Department or your doctor if an exam is required.

To enroll in kindergarten, a student must be 5 years old on or before Aug 31st. To enroll in first grade, students must be 6 years old on or before Aug 31st OR have completed an accredited Kindergarten program. These age limits are established by state law and the school district has no flexibility to adjust these requirements.

challenge to keep them maintained and updated as well as safe and secure. The second was the need for better and consistent communication between the school and community at large. Work will continue on this strategic plan this fall and we hope to have a final product by December.

One thing that is at the front of our minds is school safety. This is always something we take seriously, but the recent situation in Texas has brought the issue to the forefront once again. A few years ago we implemented the SafeDefend system in our schools. This system provides immediate notification to staff and law enforcement of the location of any threat to our school. The system also provides tools for staff to protect themselves and students from any potential threat.

I am excited about what our staff and teachers are doing in our school. Last year, one area of focus was reading interventions. At the beginning of the year, the elementary school had 56% of students meeting the target. By the end of the year we had nearly 80%. The junior high students have 90% meeting their reading goals.

In addition to the great things happening with the core curriculum, there are other things happening other classes. The business department is starting up a student-run bank this year in cooperation with SJN Bank of Kansas. This will be a great opportunity to teach students in all grades the importance of saving money. Last year the Family & Consumer Science and Business classes cooperated to form the student-run business called Tiger Coffee. That business will continue this year.

We are in the process of getting a childcare facility up and running in the building south of the library. SJN Bank donated the building to the school district for this purpose. The building is nearly ready and we are waiting on the licensing process to be finalized. Nikki Adams will be the provider. I am blessed to work with such a great group of people that are committed to the success of every student. I am grateful to be a part of such an awesome organization and supportive community. I'm looking forward to a great school year.

Early Education at USD 350

It is the goal of USD 350 to provide preschool for all children starting at age 3. Preschool students attend class for a half day Monday through Thursday in the morning or the afternoon. Preschool will be in session on some Fridays in order to meet state time requirements. The first day of preschool is Aug 18th.

Our preschool is operated jointly by USD 350 and the special education cooperative in Pratt. Students must go through the screening process to be eligible to attend preschool. If you missed the spring screenings, you can call the school office or the special education cooperative at 620-672-7500 Ext 1203 to make an appointment.

For the most part, children must also be toilet trained before attending preschool. If you have any questions, please feel free to contact the elementary office.

LIFE After-School Program

The L.I.F.E. After-School Program is available to all students (K– 4th grade) enrolled in USD 350. Enrollment in the program is only \$20 per month. A snack, an academic lesson and a wide variety of other fun activities and crafts are provided. The program is on an enrollment basis and has a low monthly fee. Parents/guardians may choose to send their student five days a week or pick the days that best meet their needs. The program runs every day immediately after school until 5:10 pm Monday-Thursday and 4:50 on Fridays.

Preliminary Budget Information

School district budgets are very complicated and can be difficult to understand at times. For the most part, the school district's budget is based on student enrollment numbers. These numbers are used in a formula to set our budget for the year. The amount of tax dollars levied by the district is dependent on the budget set from this formula and are affected by the total value of property in the district.

The property valuation in the district will vary widely from year to year. This is primarily due to the value of property tied to oil and gas which tends to be very volatile. Typically, when valuation is high, the total tax dollars collected is higher and the mill levy is lower. When valuation is low, the opposite is true. This year, the property valuation is over \$44 million and is as high as it's been in over a decade.

All taxpayers will be getting a notice in the mail regarding the estimated property tax and the "revenue neutral rate" (RNR) for the upcoming budget year. The RNR is the mill rate that would generate an equal amount of tax revenue in the coming year's budget as compared to last year. This notice will show you the difference between the RNR and the proposed budget. One important thing it does not tell you is the difference between last year's mill levy and the proposed mill levy.

The notice for USD 350 property taxes will show that the proposed rate is about 4.3 mills higher than the RNR. This gives the impression that taxes are going up. But in reality, the mill levy will be going down by about 2 mills.

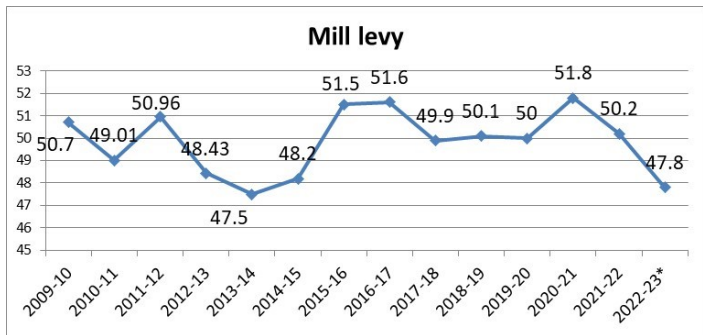
For example, if you own a \$200,000 home, the tax dollars collected for USD 350 were about \$1,100 for the previous year. Your notice will illustrate that the taxes you will pay for the coming year will be about \$90 higher than what you would pay with the revenue neutral rate. The reality is that if your home did not increase in value, you will actually be paying about \$50 less in taxes for the coming year.

It seems like the "revenue neutral rate" would just mean the district's budget stays the same, but that is not the case. In fact, to meet the revenue neutral rate, we would actually need to cut our budget. The problem lies with the general fund mill levy. State law requires that to be at 20 mills, but the RNR is 17.8. Since the required 20 mills is above the RNR, other areas of the budget would need to see a reduced mill levy to make up for this. If we were to actually set our budget with the RNR, our capital outlay revenue would need to be reduced by \$120,000.

This year's budget is not much different than prior years. There is a roughly 3% increase in general state funding for K-12 education this year. This is a positive thing for school districts in our state. But just like your household budget, we are feeling the squeeze of inflation and must find ways to tighten our belt to make up for increased costs. There is also the challenge of special education funding. Kansas law requires the state to fund 92% of the excess cost for special education. Currently that funding level is about 70%. We must make up that gap with general fund dollars. While we are seeing an increase in general state aid, some of that increase is masked by inadequate funding for special education.

In addition to the school mill levy, the district also collects taxes on behalf of the recreation commission. The recreation commission sets their own budget, the taxes are levied by the school district, and passed on to them. This levy is very similar to what it is every year 3.7 mills.

Substitute Positions

We are always looking for great substitute teachers for our classrooms. Substitute teachers earn \$110 per day and can find some work on most school days.

Substitute teachers must be licensed. However, it is not required to have a bachelor's degree. Anyone with 60 or more college credit hours may apply for a license with the KS State Dept of Education. We can help with the licensing process.

We also need quality people to work as substitute bus drivers, custodians, and classroom aides. Contact the district office at 549-3564 to inquire or apply.

Meals have been free for all for the last two years, but this is not the case for the upcoming school year. Families will be required to pay for meals unless they meet income requirements. From the Nurse's Office

Preschool, Kindergarten, and new students eight years old and under will need to have a health assessment on file at school and proof of immunizations. All students please bring proof of any new immunizations to the school office.

If your child will be taking prescription medications at school, carrying an inhaler, or have an allergy and need an epi pen you will need to have a **NEW** medication form signed by your doctor and have it on file at school. Students in grades 7-12 are allowed to carry over the counter medications in their backpack.

If your child tests Positive for COVID-19, please contact the school. We will send a note home if someone in a class has covid so you can watch your child for symptoms. There will be no quarantine this year. We are counting on parents to help us keep the spread to a minimum this school year.

If a student has COVID-19, regardless of vaccination status, the CDC guidelines state a student must:

- Stay home for 5 days.
- If they have no symptoms or their symptoms are resolving after 5 days, they may leave the house. They may test on day 6. If they are negative, they should continue to wear a mask around others for 5 additional days or stay home if they don't want to mask.

If they have a fever, they must continue to stay home until the fever resolves.

We will be offering free rapid covid tests, free strep throat tests, and free flu a/b tests this year as part of our program from KDHE. My understanding is we will also have home covid tests available at some point during the year.

If your child has any special health needs or you have concerns about your child please let me know. I'm looking forward to a fun and healthy year with your children!
