CITY OF HUDSON, KANSAS, ORDINANCE NO. 147

A JOINT ORDINANCE AND RESOLUTION RELATING TO THE CREATION OF A JOINT RECREATION COMMISSION BY UNIFIED SCHOOL DISTRICT NO. 350, THE CITY OF ST. JOHN, KANSAS, AND THE CITY OF HUDSON, KANSAS, (Pursuant to K.S.A. 12-1901 et seq.)

BE IT ORDAINED BY THE GOVERNING BODIES OF UNIFIED SCHOOL DISTRICT NO. 350, THE CITY OF ST. JOHN, KANSAS, AND THE CITY OF HUDSON, KANSAS:

RECREATION COMMISSION: ESTABLISHED. There shall be a Recreation Commission of Unified School District No. 350, the City of St. John, Kansas, and the City of Hudson, Kansas, and the same is hereby created and established. (K.S.A. 1980 Supp. 12-1902 and K.S.A. 12-1907)

COMMISSION: DUTIES AND AUTHORITY. The Commission shall operate a system of public recreation and playgrounds, acquire equipment and maintain land, buildings or other recreational facilities, employ a superintendent of recreation and assistants, vote and expend funds for the operation of such a system. Said commission shall be authorized to conduct the activities of the system on any property under its custody and management, or, with proper consent, on any other public property and upon private property with the consent of the owners, and may receive gifts from any source whatsoever. (K.S.A. 12-1901:1903)

COMMISSION MEMBERS: APPOINTMENT, TERMS OF OFFICE. The governing body of Unified School District No. 350 shall appoint two (2) of its electors, the first selected shall

serve for a term of one (1) year, and the second for a term of four (4) years. The governing body of the City of St.

John, Kansas, shall appoint one (1) of its electors to serve for a term of three (3) years. The governing body of the City of Hudson, Kansas, shall appoint one (1) of its electors to serve for a term of two (2) years. The fifth member of the Joint Recreation Commission who shall serve for a term of four (4) years shall be appointed by the four (4) appointed members of the Commission. (K.S.A. 12-1907)

COMMISSION: ORGANIZATION. The Commission shall organize itself to administer in all respects the business and affairs of the recreation system. The treasurer of Unified School District No. 350 shall be ex officio treasurer of the Commission. (K.S.A. 12-1907)

COMMISSION FUNDS. Funds received by the Commission from a tax levied by Unified School District No. 350 pursuant to K.S.A. 1980 Supp. 12-1908 and from whatever other source, shall be used by said commission for the purposes herein set out and shall be held by the treasurer of Unified School District No. 350. The Commission shall maintain financial records as required by law, submitting the same to an annual audit as provided by law, and a copy of such annual audit report shall be filed with the governing body of Unified School District No. 350. (K.S.A. 12-1907 and K.S.A. 1980 Supp. 12-1908)
